## **CONTINGENCY PROGRAM**

PRP Seats Contingency Program rewards approved drivers with PRP Seats "Racer Bucks" as they reach the podium in their approved race as well as a discount on PRP Seats products. Only approved members in good standing will qualify for PRP Seats Contingency Program. Teams must fill out a complete application and all races on application must be attended to remain a member in good standing. Once approved, the participant will receive a login to the PRP web site where they can purchase items at discounted prices through the online store at PRP-Seats.com.

## **REQUIREMENTS & DETAILS -**

- ALL Contingency Program products MUST HAVE THE PRP SEATS LOGO APPLIED IN THE APPROVED MANOR.
   All seats must have the PRP Seats logo embroidered on the front of the headrest. UTV seats must have the PRP Seats logo on the back of the head rest as well. Limit straps, window nets, and seat belts must have the logo in the factory location.
- Approved PRP Seats Logo decal must be located on each side of the race vehicle. PRP Seats can supply decals. Supplied decals must
  not be altered in any way without approval. Any logo as part of a vehicle wrap or decals produced by the racer must be approved by PRP
  Seats in order to qualify. Send artwork proofs to team@prpseats.com.
- Racers are required to report back to PRP Seats after each race with their results to (1) confirm they are continuing to participate and
   (2) notify PRP Seats of any Racer Bucks earned. PRP Seats will not be following the various races. It is up to the racers to keep PRP
   Seats informed. Should the racer fail to report their race activity within 14 days following the race, PRP Seats reserves the right to
   suspend or remove the racer from the PRP Seats Contingency Program. Submit your race reports to team@prpseats.com.
- In order to qualify for earning Racer Bucks the race must have at least 5 participants. In the event a race includes multiple heats (or "motos"), the overall standings will determine Racer Bucks rewards.
- PRP Seats' Contingency Program is an ongoing marketing campaign and PRP Seats reserves the right to change the terms of or cancel the program without prior notice.
- PRP Seats Contingency Program participants must present a positive image of PRP Seats at all times or may face removal from the program.

#### **RACER BUCKS** -
